400.5(1) **Policy Name**

Lunch-time Bussing

400.5(2) Policy Statement

- 400.5(2.1) Nova Central School District may provide lunch-time bussing for students on a school-by-school basis where the following criteria have been met:
 - a. Students are regularly bussed to and from school;
 - b. It can be accommodated within the existing transportation system (e.g. buses, drivers);
 - b. It will not negatively impact the bussing for students at other schools;
 - c. The majority of parents are in support of lunch-time bussing;
 - d. The cost of lunch-time bussing is recoverable through user fees;
 - e. Students will normally have at least twenty minutes at home during the lunch break.
- 400.5(2.2) Where lunch-time bussing is provided, students are expected to travel home for lunch unless the student transportation subdivision deems that it is not feasible to transport a student over

- the lunch break (e.g. lives too far away) or a student is otherwise authorized to stay at school by the principal or his/her designate.
- 400.5(2.3) Where it is necessary for students to stay at school because they live too far away from the school to travel at lunch-time, the principal shall arrange for appropriate supervision of the student(s) during the lunch break. All other arrangements for supervision at lunch time shall be at the discretion of the principal.
- 400.5(2.2) Lunch-time bussing shall be reviewed annually to ensure the continued feasibility of bussing students home at lunch-time.

400.5(3) Policy Rationale/Purpose

Lunch-time bussing is appropriate in certain situations and can provide a break at home for students during the school day. However, it is only feasible for some schools and funding for lunch-time bussing is not provided in the *Pupil Transportation Fund* allocated to the district by the Department of Education. Therefore, it can only be supported on a cost recovery basis.

400.5(5) Scope

This policy applies to all schools in Nova Central School District.

400.5(6) Roles and Responsibilities

Responsible Division: Finance and Administration
Responsible Area: Student Transportation

- 400.5(6.1) The **Assistant Director of Education for Finance and Administration** shall be responsible for the implementation, monitoring and revision of the Lunch-time Bussing Policy and shall approve any implementation of lunch-time bussing.
- 400.5(6.2) The Manager of Student Transportation or the Manager of Administrative Services shall review requests for lunch-time bussing and make a recommendation to the Assistant Director of Education for Finance and Administration as to its feasibility at individual schools.
- 400.5(6.3) **School administrators** shall ensure that
 - Requests for lunch-time bussing are submitted to the Manager of Student Transportation or the Manager of Administrative Services

- c. User fees are collected and submitted to the district to cover the costs
- d. Students have adequate time at home during the lunch break.
