# **Effective Use of Instructional Time**

# 800.10(2) Policy Statement

Nova Central School District will make every effort to protect instructional time, and ensure that activities that occur during instructional time enhance learning and cover curriculum outcomes.

800.10(2.1)

School administrators are expected to:

- Keep the 'big picture' in mind when considering activities which interrupt instruction, and maintain an appropriate balance between such activities and regular instruction.
- b) Regularly review the overall impact of such activities on instructional time.
- c) Minimize daily interruptions to instructional time such as PA announcements, assemblies and rehearsals.
- d) Develop school calendars at the beginning of the school year to identify, as much as possible, those activities which will impact instructional time.

800.10(2.2)

Activities by external agencies and individuals that require instructional time shall support curriculum outcomes and generally be limited to specific classes or cohorts of students versus being offered for the whole school.

800.10(2.3)	All other activities facilitated by external agencies or individuals shall be prioritized and planned for times other than during instructional time (e.g. lunchtime, after school).
800.10(2.5)	Each school facilitates special events such as spirit days, winter carnivals and healthy living fairs. However, such 'days' can consume an incredible amount of instructional time. Students should spend no more than 20 hours of instructional time each year participating in such events.
800.10(2.6)	District and school staff are expected to coordinate professional development sessions so that the impact on instructional time and teacher time away from the classroom is reduced where possible.

### 800.10(3) Policy Rationale/Purpose

Research demonstrates a clear link between quality instructional time and student academic achievement. In the course of the school year, significant instructional time is lost due to non-instructional activities and disruptions to teaching.

Nova Central School District recognizes the importance of providing a holistic learning environment for all students, including the provision of extracurricular activities and social events, as well as the promotion of physical activity. The district also recognizes that some interruptions are beyond the control of school staff. However, the district must strive to ensure that curriculum outcomes are covered and students receive the supports they need to achieve to their fullest academic potential.

800.10 (8.1) INSTRUCTIONAL TIME

Usually defined as the time allocated by the provincial Department of Education and the school district for instruction.

It is recommended that schools develop their own policies with respect to the effective use of instructional time, in accordance with the district policy.
