800.1(1) **Policy Name**

Student Participation in Alpine Skiing/Snowboarding

800.1(2) Policy Statement

Nova Central School District supports the participation of students in alpine skiing/snowboarding activities, provided that all reasonable safety measures are in place for the protection of students.

800.1(3) Policy Rationale/Purpose

Skiing and snowboarding are enjoyable sports that may be offered as part of the Physical Education curriculum for students. However, they are also sports with physical demands and inherent risks. This policy, and its related procedures and guidelines, is intended to ensure that when Nova Central School District students go downhill skiing or snowboarding, the safety of the participating students is the most important consideration.

800.1(5) Scope

This policy applies to:

800.1(6) Roles and Responsibilities

Responsible Division: **Programs**

- 800.1(6.1) The **Assistant Director of Education (Programs)** shall be responsible for the implementation, monitoring and revision of this policy.
- 800.1(6.2) The **School Administrator** or his/her designate shall be responsible for the planning of all alpine skiing/snowboard trips including obtaining parental consent, arranging for orientation and instruction of students, ensuring there is appropriate supervision and applying limitations where required.
- 800.1(6.3) The **Teacher(s)** who accompany students on skiing/snowboard trips shall be responsible for the supervision and control of students and ensuring that appropriate safety measures are followed.
